There was serious concern that the noise report is invalid as it was not carried out during a 'neutral period. AGREED response: Whilst the Parish Council broadly supports the development there are concerns with regard to the roundabout 1. Noise & vibration nuisance 2. Invalid noise/count report which relates solely to properties within the development. Suggested area for a new survey agreed. 3. Acoustic glazing should be offered to all properties affected within the radius of the roundabout 4. Consideration should be given to an acoustic barrier. 5. Noise mitigation measures must be in place before any construction work commences 6. Lack of 'stop' and 'give way' signs present safety hazard

T&MBC has agreed to temporary deferment of the grant as the project has been delayed because of the proposed roundabout j/o A25/Western Rd.
