Chairman will arrange meeting with Wrotham and Ightham PC representatives re. proposed bypass. A recent traffic count A25 and A227 was carried out by Babtie. A copy of the results will be requested.

Village Enhancement 84

Chairman and Clerk met with T&MBC to discuss installation of a seat and planter at entrance to Western Road car park. Comments from adjacent residents will be invited. For further discussion at the next meeting.

Report of the Finance Cttee. 85.

All Clirs were given copies of the budget report – period ended 30/09/01. Clerk reported Finance Cttee recommendations: 1. Fidelity Guarantee Insurance to be increased to £75,000. 2. Shortfall in allocated money for Potters Mede rates to be met from reserve account. Chairman proposed that these recommendations be accepted. Agreed.

T&MBC Financial Arrangements with Parish Councils 2002/2003 86.

Chairman outlined Finance Cttee recommendations for T&MBC Special Works Grant 2002/03: Further enhancement of Recreation Ground 1. 2no sprung rockers in children's play area + safety surfacing £2735 + VAT. 2. Fencing 3<sup>rd</sup> side of play area adj. to stream guideline price requested from Chestnut Products Ltd. 3. Concrete base and fixing of loose seat in play area £250 + VAT approx. 4. Replacement bridge over stream and construction of dog walking track through woodland – guideline price requested from Medway River Project. Chairman proposed that these recommendations be approved and a grant application made. Agreed.

87. Recreation Ground

Mowing: Chairman proposed that a quotation be accepted from KCC in the sum of £26.50 per cut less £1.56 per cut if both grounds are cut on the same occasion. Agreed.

88. **Potters Mede** 

Mowing: Chairman proposed that a quotation be accepted from KCC in the sum of £50.26 per cut less £1.56 per cut if both grounds are cut on the same occasion. Agreed. Noted that due to frequent wet condition of Potters Mede it is becoming increasingly difficult to cut both grounds on the same occasion.

Cricket Square: Grounds maintenance staff will cut the square as a matter of priority. Christmas tree recycling: Agreed that car park can be used by T&MBC as a collection point, all as in previous years.

Car Park fence: Tonbridge Fencing will be instructed to repair vandalised fence.

Ladies' Cloakroom: Agreed to purchase replacement door.

Sports Facilities: There was some discussion about possible future sports provision at Potters Mede and Whitegate Field.

Committee Reports 89.

Highways, Footpaths & St.Lighting; A light in the High Street is not working. BGVHMC: Trees overhanging the footpath need to be cut back. Agreed to support BGVHMC's application to T&MBC for a grant towards resurfacing the car park. Cllr Evans will refer these matters to the cttee.

Men of Trees: A written report was read. Copies will be sent to BMPOS cttee and BG School. Cllr Brinkley-Willsher will include Basted House in next year's tour of the village. Quarries Liaison: Cllr Hughes reported on a recent meeting of Stangate Quarry Liaison Cttee. Chairman reported on recent meetings of RMC, Celcon and Nepicar Quarry. BMPOS: A request for £1400 annual maintenance grant was received. Chairman proposed that this be paid. Agreed.
