131. **Highway Matters A25**

Chairman reported on the works being undertaken by Southern Water due to the collapse of a sewer. Tree Planting: Councillors have considered T&MBC tree planting proposals 2003/04 and agree with suggested locations at Potters Mede and the Recreation Ground.

Tree surgery: Two requests for tree surgery at the Recreation Ground have been received (a) Sycamore overhanging 4 Monckton Road (b) Oak tree SE corner of the bowling green. Clerk reported on advice received from the Trees Officer T&MBC. Cllrs Brinkley-Willsher and Mrs Lucas will make site inspections and report back to the meeting in February.

Mowing: A quotation for the 2004 season was received from KCC - Potters Mede £54.36/cut Recreation Ground £28.67/cut with a discount of £1.68/cut/per site if both sites are cut at the same time. Noted that the latter is often difficult because of water retention at Potters Mede. Cllr Brinkley-Willsher proposed that this be accepted, seconded by Cllr Mrs Woodhams.

BGFC: The Football Club ask for further consideration of their request to play at the Recreation Ground. Clerk summarised the points they raised. Agreed that this will be discussed at the RGMC meeting although councillors still stand by their decision that adult football should be played at Potters Mede.
