

Appendix 2 Enforcement letter

Dear Cllr Taylor.

Enforcement Investigation: Isles Quarry, Quarry Hill Road, Borough Green, Sevenoaks, TN15 8PG.

Thank you for providing information in response to our investigative questions relating to this matter.

Although parts of the area are protected and development restricted, the Council is closing its investigation on that basis that it is not expedient to take enforce action due to the following factors;

- There is no evidence that the ancient woodland has been damaged or impacted by the regrading of the land.
- The images provided show no damage to the trees
- The bike track is isolated and only accessed by locals
- There are no signs of further expansion and a lack of evidence confirming when the track and associated jumps etc were constructed

In confirming this position, I would like to remind you that given the site's close proximity to the protected ancient woodland area, any expansion would likely require planning permission.

Appendix 3 KCC Road closures

Temporary Road Closures – VARIOUS ROADS, TONBRIDGE & MALLING – from 5TH May 2026 for up to 18 months

Because of carriageway resurfacing and joint repair works, Kent County Council has made an Order prohibiting through traffic on Various Roads, Maidstone & Tonbridge & Malling as per the schedule below.

This Order takes effect on or after 5th May 2026 for a period of up to 18 months or until the works have been completed. Planned dates will be published in advance of the works and indicated by signage displayed on site 14 days before they start. This programme is subject to weather and other factors and may therefore change; every effort will be made to keep as close as possible to the programmed dates and duration. Changes will be notified locally and signposted on site.

A227 Wrotham Bypass, A227 Borough Green Road, A227 Wrotham Road, A227 Western Road & High Street, Borough Green

Between A20 London Road and A25 Sevenoaks Road in 2 phases to ensure Borough Green train station remains accessible throughout works duration, from 22nd June 2026 with estimated completion by 8th July 2026, between the hours of 20:00 and 05:00 only as detailed below:

Phase 1

A227 Western Road, A227 Wrotham Road

Between A25 Sevenoaks Road, Western Road and Station Approach (Car Park access to be managed).

High Street

Between A227 and Borough Green Village Hall. Primary diversion via A25 Sevenoaks Road, A25 Maidstone Road, A20 London Road, A227 Wrotham Bypass, A227 Borough Green Road, A227 Wrotham Road and vice versa.

Phase 2

A227 WROTHAM ROAD, A227 Borough Green Road, A227 Wrotham Bypass

APPENDIX 4 SOUTH EAST WATER REG 18 RESPONSE

Extract re housing numbers - full letter on Website

Specifically, in the Tonbridge and Malling area, where we currently lack available headroom in our supplies, we would be unable to accommodate any growth exceeding our WRMP24 forecast assumptions throughout the entire planning period. This is because our WRMP24 was developed to balance supply and demand based solely on the growth forecasted and provided to us in recent years.

We have completed an assessment to compare your latest growth forecast figures (using your IDP datasets) against the forecast we used in our published WRMP24, please see the comparison below:

We would like to highlight that the housing numbers proposed in your latest IDP in the period 2025-42 are considerably higher than we have in our WRMP24 forecast. Due to the current supply-demand situation in our WRZ1 (Tonbridge Wells), WRZ6 (Maidstone) and WRZ7 (Cranbrook) water resource zones, this increase causes significant stress to our supply system. To assess the impact beyond our current WRMP24 forecast, we would need to recalculate our demand forecast and rerun our decision-making process. This would help us identify additional interventions, such as new supplies, transfers, or increased demand reduction programs, which would not be known until we complete the work for our next plan, WRMP29.
