274. Submissions by County and Borough Members and Members of the Public

PC McElligott reported on the few ASB actions in the Rec, High St and Sainsbury. He will be holding a surgery with the Clerk outside Nisa on 13th November, and passed on Kent Police's apology for not attending the possible shotgun incident in the Rec. Chairman thanked PC McElligott for attending.

Cllr Harry Rayner KCC reported on the impact of recent Mineral submissions on the Local Plan.

Cllr Wendy Palmer TMBC announced the Local Plan meeting on 28th November in the Village Hall led by TMBC Leader Matt Boughton and the Cabinet Member for Planning, and urged people to attend and have their say. She also reported on the recent Parish Alliance meeting on LGR, and how the Parishes would be submitting a joint response to the consultation which ends 28th November.

Appendix 2 Pavilion Works update Date: 3rd November 2025

Project Manager: Cllr Nikki Proto

Project Team: Cllr Mike Taylor (BGPC Chairman), BGPC Clerk Bernie Galopin

Contractor: Honeycomb Construction Services Limited

The main pitch roof is almost completed. The aluminium fascia to the rear should be installed in the next couple of weeks. The build materials for the bespoke cupola and the clock have been ordered. The clock can take up to 4 weeks for delivery so Paul will build and fit the cupola and then fit the clock once it arrives.

The flat roof to the former shower room has been redone. Paul needed to raise the gable wall by two courses of bricks, 2/3 of the way round and it has been insulated with 150mm PIR insulation to now comply with the required thermal values as set out in the BRegs.

The total cost of works for the pitch roof, cupola and flat roof is around £18,500.

The next stage of the project is to install an accessible ramp. The ramp will be cut into the bank to the left end of the Pavilion and lead to the large, uncovered end of the veranda. Paul has provided an estimate of around £5,500. Hardcore left from the roof works can be recycled and used in the ramp's construction. Paul will familiarise himself with the recommendations for the ramp's construction set out in the DDA Audit report.

TMBC Building Control will be contacted to establish which BRegs apply.

TMBC Planning Office will also be contacted to check whether planning permission is needed.

Appendix 3 BGPC Responses to Nepicar Sandpit & BG Sandpit applications

KCC/TM/0157/2025 . Nepicar Sand Quarry S73 application to amend TM/20/2248 working and restoration scheme. Strong support for the application. It makes logical sense to extend existing sites rather than open new sites in virgin countryside, and the operator generates very few complaints. There was a note of caution from members about excavating too close to the boundaries because of collapse hazard - there were multiple collapses at the adjacent Borough Green Sandpit caused by vertical excavation faces close to the boundary, resulting in rerouteing of the PROW, and significant risk of harm to operators and the public

KCC/TM/24/958/RVAR BG Sandpit conditions 1, 24 and 30 of TM/24/958, update of the surface water scheme at Borough Green Sandpits, amendments to the approved restoration scheme.

BGPC Observations: Extreme concerns about Landform and Flood Risk.

1. The Operator has shown a cavalier disregard for proper site management, as indicated by the regular complaints about mud on the highway, noise, working hours, and windblown sand.

2. The landform here has been raised significantly above the original ground level, resulting in the need for an attenuation pond that is pump fed because of the reverse fall , The flow from a stream coming south from the M26 area onto the site has to be pumped up into the existing attenuation pond. In 2014 lack of monitoring of the pumping caused an overflow breach to the banks of the attenuation pond, resulting in a tsunami of silt laden water that ran under the railway where it blocked the culvert to Griggs Way and flooded gardens in Lingfield Rd and Sandy Ridge. Network Rail took action against the operator, and we were in regular contact with Emmanouil Tsoukalas who can probably provide some further insight into those issues.

3. We know the landform used to fall southwards across the site from 93m aod on the untouched field in the north, to 88m aod at the base of the railway embankment. I know the field used to be virtually flat because I worked for ARC in the 70s and mowed the field regularly for the BG Football Club practice. The landform now rises at a sharp angle almost matching the height of the embankment top. I see from the submitted plans that the Operator intends

to top out this huge heap at some 98m aod which is significantly higher than the railway embankment, and some 10m (30ft) higher than it should be.

4. There does not seem to be a coherent plan to the new landform - instead of restoring to the original 93m-88m gentle fall southwards, and a reasonably level field, it is planned with lumps and bumps at random, at one point in the east of the site being left with a valley down to 80m aod.

Planning rules require restoration to pre-excavation levels, and whilst a different level can be approved, that needs a separate approval, not just sneaked in under the radar like this. And a reminder if needed - water does not flow uphill - this scheme will require pumping, and who will pay for, monitor and maintain that?

The landform needs to be reinstated to its past levels, and the stream routed along its original path, which can be clearly seen on the Google Earth historic imaging.
