The effect of the proposed named Order is to extend/reduce the lengths of the Speed Limits in Platt/Borough Green in the following lengths of road;

1. Extending the lengths of the 30mph Speed Limit in Platt/Borough Green in the following roads

#### Maidstone Road (A25)

From a point 289 metres northeast of its junction with Pine View to its junction with Sevenoaks Road

#### Sevenoaks Road (A25)

From its junction with Maidstone Road to its junction with Borough Green Road

#### **Borough Green Road (A25)**

From its junction with Sevenoaks Road to a point 230 metres west of Western Road

#### 2. Reduce the extent of the 40mph Speed Limit in Platt in the following roads

#### Maidstone Road (A25)

From its junction with London Road to a point 289 metres northeast of its junction with Pineview

## 3. Reduce the extent of the Derestricted Speed Limit in Borough Green in the following roads Borough Green Road (A25)

From a point 230 metres west of Western Road to its junction with Ightham By-Pass
