## 125. Period for Public Consultation

- (i) The positions and wording of signs in the Recreation Ground, and publicity in The Voice re dog fouling is considered inappropriate by some. Chairman stressed that it is appreciated that there are many responsible dog owners. However, strong words are needed to deter offenders and a complete ban in BGPC controlled areas would be a last option and only after public consultation
- (ii) A resident stated that to spend a considerable amount of money on improved watering arrangements at Potters Mede is not right and the council should reconsider this.
- (iii) KCCllr Rayner reported on the Big Bus Conversation Summit and the KCC Utilities Sub-\cttee: UKPN has indicated that sub-stations in the area are at capacity.

Chairman proposed that item 134 of the agenda be taken next. Agreed. Chairman RESOLVED to enter into committee to exclude the public and press from the meeting due to the confidential nature (financial and other sensitive information) of the discussions.
