8. Borough Green & Platt Bypass/Traffic Matters

Reply from KCC re traffic matters in Borough Green and traffic calming, read and noted. Members met on site with KCC and the Police, to discuss recent A227 works and prioritisation alterations. There are some practical concerns which KCC is currently considering. Additionally, lack of direction sign to Maidstone at j/o Western Road/Sevenoaks Road is confusing. There is also concern that this junction is extremely difficult for articulated vehicles to manoeuvre.

There were no matters for public consultation.

9. Vacancies BGPC

The recent Parish Council election was uncontested and there are four vacancies which may be filled by co-option. Copies of two letters of application were given to all Cllrs. Chairman proposed that Mrs Phyllis Anderson and Mr Chris Merritt be appointed as co-opted members of BGPC. Agreed.

10. Seeboard Street Lighting - Charges 2002/2003

Cllr Hughes proposed that the revised monthly charge of £168.47 for energy be accepted. Seconded by Cllr Taylor. Agreed.

11. Recreation Ground

Use by Youth Group: A working party from 'The Joint' would like to paint the pavilion prior to the Village Fete in June. An associated barbeque for the volunteers is planned. Chairman proposed that this be agreed and painting materials be added to the Parish Council's account at Kent Aluminium. Agreed. Cllr Taylor will make the necessary arrangements. Tennis Courts: A letter from the Tennis Club was read. Agreed that no action will be taken at present ragarding resurfacing of the courts. Noted, however, that full resurfacing works will be required in two years time. Financing the work will be considered at the 2004/2005 budget meeting. Chairman proposed that the broken tennis court post be replaced by Trevor May Ctrs for the sum of £120 + VAT. Agreed. Further agreed that charge for hire of public court will not be increased for this financial year but, again, this will be considered at the budget meeting.

12. Potters Mede

BGJFC request use of the ground for two small/junior-sized football pitches. After discussion, agreed in principle but require more details.

13. Committee Reports

Highways, Footpaths & Street Lighting: New direction sign to library o/s entrance to village hall car park is an obstruction for wheelchair/pushchair users. Nearby pothole needs attention.
