Minutes of the **BOROUGH GREEN PARISH COUNCIL MEETING** held at the **COGS Annexe** on **Monday 7th April 2025** starting at **1930**. The meeting was not recorded. ### **202. Submissions by County and Borough Members and Members of the Public**

Before Cllr Rayner spoke, Chairman noted that the imminent KCC elections prevented Cllr Rayner from a full report, but thanked him for his hard work over the years, his deep commitment to all his Parishes, and wished him well in the Election.

**Cllr Rayner KCC** reported the implementation of Operation Brock again. The recent good weather has seen an increase in migrant small boats, and an increase in unaccompanied refugee children, putting great strain on KCC resources. But on a positive note SEND Transport costs had fallen by 10% compared with last year. The current Government has committed to keeping its Bus Service Improvement Grants (BSIP) which means the well use Parish Alliance buses will continue to be funded for the foreseeable future.

**Cllr Palmer TMBC** reported on the recent water outages, and a subsequent meeting with SE Water where they were told in no uncertain terms that their communications needed to be improved, and that Vulnerable Users lists and Bottled Water points needed to be put in place now, not scramble around after an event trying to plug the gaps. Clerk & Cllr Butterfill will be investigating resilience planning.
