### 7. Oral reports from Members and Clerk

Cllr Broad advised of his discussions with the Police about anti-social behaviour. The response to his report has been very positive.

Report from the Junior FC: it is continuing to progress ideas for an all-weather pitch with Wrotham School - at some stage a request for a grant may be made to the Parish Council; the club may be able to assist with a grant application for Potters Mede; clearance of ditches at Potters Mede is requested.

All councillors and members of the public received copyright data from Cllr Perry on the one month trial of a portable traffic-speed monitoring device. The equipment had been set up on Maidstone Road and Sevenoaks Road. Cllr Perry explained detailed information and thanks were expressed to him for undertaking this project. Full details of the data collected are available in the Parish Office. Agreed to return the equipment and give further consideration to the purchase of appropriate equipment.

T&MBC will be asked to request reinstatement of ground around recycling bins at the railway station.

It is likely that planning application will shortly be submitted for recycling operations at Borough Green Sandpit.

Sir John Stanley MP is continuing to investigate legalities of recently-installed O<sub>2</sub> equipment in Fairfield Road. Written comments can be sent to the contact address displayed on the cabinet.

Repairs and required to the fencing of the Jubilee Field, Quarry Hill Road. Gullies in the High Street need emptying.

There then followed the period for public consultation:

Items relating to maintenance and use of Recreation Ground pavilion were raised. The meeting was reminded of the KCC planning meeting 16 May 2006 re the Celcon application. Residents were encouraged to attend.

Chairman will seek further information on the current drought and supply of water. The Police reported that instances of anti-social behaviour have decreased over recent weeks.

Cllr Broad and Cllr Mrs Lucas be in attendance at the Parish Office 10-12 noon Saturday 10 June 2006.

## 11. CDRP committee/anti-social behaviour

A suggestion from T&MBCIIr Mrs Murray for a large CDRP sub-committee was received. Chairman reported on advice received. All members received copies of guidance notes from T&MBC. After discussion it was agreed that residents and representatives from all local organisations be invited to a meeting to discuss the formation and future role of a local committee to help address problems of anti-social behaviour in Borough Green.

## 12. Recreation Ground car park & proposed 'Ingleside' development.

Chairman proposed that additional solicitor's costs in the estimated sum of £500 be agreed + £1,200 for negotiation and completion of Section 106 agreement if required. Seconded by Cllr Perry. Agreed. For further discussion under item 15 of the agenda.

# 13. Recreation Grounds

**Toilets:** Hours of opening 8.30 am - 9/10 pm agreed. Further agreed that the facility will be closed earlier if there are any problems of anti-social behaviour.

**Bowls Club rent:** An revised annual rent of £800 has been agreed w.e.f 1 July 2006. **Byelaws:** A letter from the ODPM was received. Chairman will report to the next meeting. **Potters Mede car park and drainage:** A letter from Platform Rentals was received: Clerk summarised details regarding their willingness to pay for use of the car park December – April incl. at rates previously agreed + occasional parking of 3-4 additional cars. Chairman proposed that this be agreed. Agreed.

There was further discussion about the quotation from Waterlink for replacement water supply pipe. Cllr Bailey will supply details of an alternative contractor.

**Potters Mede pavilion refurbishment and windows:** Notification of contractor's 5% price increase w.e.f June 2006 noted. Cllr Perry proposed that instructions be given to Simmonds of Wrotham for Phase 2 of the works – all in accordance with their tender previously submitted and the foregoing, to a maximum cost of £2,500.00. Seconded by Cllr Mrs Lucas. Agreed. Priority will be given to security and Health & Safety related items.

There was concern about the recent instances of vandalism to windows. Alternative methods of glazing discussed. Chairman proposed replacement of damaged polycarbonate panes in hall pending further discussion at the next meeting. Cllrs Mrs Woodhams and Perry will seek professional advice.

**Use of Potters Mede:** A booking for a 'Fun Day' incl extensive use of field 12 August 2006 was discussed. Agreed that Clerk will negotiate additional fee.

**Use of Recreation Ground:** A request from General Underground Services for temporary access to the rear of properties in Monkton Road was agreed.

**Recreation Ground gates:** Clerk reported on advice and alternative estimates from Hyders. An offer from Cllr Bailey to remove and dispose of the gates at no cost was gratefully accepted.

**Recreation Ground pavilion:** Agreed that grounds maintenance staff will fit outside lights to the Recreation Ground pavilion and carry out some refurbishment of clock tower – approx cost of wooden tiles £30. The ground is looking extremely good.
