92. T&MBC Financial Arrangements with Parish Councils 2001/2002

Chairman proposed that a grant application be made to T&MBC for FY 2001/2002 for 50% of the cost of hanging baskets 2001. Agreed.

Cllr McWilliam advised of the forthcoming White Paper of the future role of Parish Cllrs. Agreed that this will be discussed in conjunction with a local government Green Paper when they are both available.

93. Recreation Ground

Refuse Bin: Chairman proposed that an additional rubbish bin be purchased for the play area. Agreed.

Seat: Chairman proposed that the new seat be installed in the play area. Agreed.

94. Potters Mede

Christmas tree recycling: Agreed that car park can be used by T&MBC as a collection point, all as in previous years. Agreed.

Farningham Cricket Club: A request was received for use of the cricket square next season. Councillors welcomed this interest. Chairman and Vice-Chairman will meet with the club representatives to discuss this matter further.

Use by Scouts: The Beaver and Cub groups are meeting at Potters Mede for 3 weeks whilst urgent work is being carried out on the Scout hut. Chairman proposed that a nominal charge of £5/session be made. Agreed.

Woodland: Chairman advised that for a cost of approx. £300 a BMX track could be constructed in the woodland. Chairman proposed that advice be taken from T&MBC and the insurance company and, if satisfactory, this facility be provided. Agreed. Further agreed that there must be a designated way to the track, around the edge of the field.

Showers: Cllr Dolton reported that the pipework, showerheads and pressure are now satisfactory. However, the heater is in a poor state of repair and will soon require attention. Noted.

Pond: Cllr Dolton advised that the drain from the pond and the fencing between the pond and the boundary will soon need attention. Noted.

Youth Group: Chairman reported that praise had been expressed by KCC for the successful youth group which is of great benefit to the community.

Car Park: Agreed to write to Wrotham School expressing concern about the extensive use and treatment of Potters Mede car park for delivery/collection of children . A request for a financial contribution will be made.
