CALL FOR SITES ANALYSIS

This is an attempt to analyse the progression from the Call for Sites into the Draft Local Plan selected sites.

It is complicated by several factors

- 1. The site numbers used in the Call for Sites are replaced later by letters, and some sites with LP numbers.
- 2. Nowhere in the Call for Sites assessment is any mention made of Metropolitan Greenbelt, but AONB is. Strange that one constraint is considered, but the other one isn't.

There were a total of **263** sites put forward in this part of the Plan of which **34** were selected for development, in order to achieve the **6828** total generally accepted as the aim of this part of the Local Plan.

What they started with: TMBC's assessment of the submitted sites:

26,591 houses submitted deemed suitable and deliverable,

8906 suitable but undeliverable,

6754 included in this plan

2387 deferred to the next plan.

6828 houses were selected for the Plan,

3234 of those came from the "undeliverable" list.

4485 houses in GREENBELT,

12683 from the Suitable and Deliverable list were not used.

Why did TMBC use those 4485 GREENBELT sites and leave 12683 suitable and deliverable houses unused?

The guiding principle for development in Greenbelt is that all other sources of land are used up, before Metropolitan Greenbelt is used, and even then it needs "Exceptional Circumstances".

That is not the case here. As the table below shows, **11724** houses were left unused from the **12681** selected and deemed "Suitable but Deliverable", and **4485** houses in Metropolitan Greenbelt were selected for the Plan.
