12. Potters Mede

Football equipment – A new goalpost has been purchased to replace missing one. Cllr Perry proposed that the quotation from Landscape Services for maintenance work to pitches in the total sum of £609.44 be accepted. Seconded by Cllr Cole. Agreed. **Football Club liaison** – Cllr Cole will liaise with Potters FC re their future plans at Potters Mede

Wrotham School liaison – Chairman has liaised with Wrotham School re future sports and community facilities. He will arrange a convenient date for Chairman, Vice-Chairman, Cllr Cole and football club representatives to meet with the Headteacher.

Fencing – Advice and a budget quotation for repairs to the inner car park fence will be obtained. Subsequently it is likely that competitive quotes will be required.
